Donor funded Scholarships and Prizes for 2017 – Office of Alumni and Philanthropy.

All **new** donor funded scholarships will fit one of three models, being Equity, Excellence or a mix of Equity/Excellence and must meet the minimum requirements set out below. All scholarships are based on standardised conditions and selected by established Selection Committees made up of Senior Management and specialist experts in the chosen fields;

Equity Scholarships - ATAR pass/GPA 4

Equity/Excellence Mix – ATAR 75/GPA 5

Excellence Scholarships – ATAR 95/GPA 6

SCHOLARSHIPS

Shaping Futures Scholarships (Equity Based)

Shaping Futures Scholarships are provided to undergraduate students at \$4,000 per year, and are intended to support academically capable students who are facing disadvantage. These students are often at risk of not being able to complete their studies without receiving some financial support in the form of a scholarship. The scholarships are funded through the Shaping Futures Endowment Fund to which donors contribute. By pooling the donations, the fund receives investment earnings on the pool of capital and therefore increases the longevity of donors' support and maximises the benefits to students. Shaping Futures Scholarships can be established within a specific discipline such as Medicine. Donors can contribute any amount towards the fund and if they are below the minimum level will be pooled with other donors to reach the

Equity Scholarships are aimed at eight areas of disadvantage that recognised by UAC.

(Carer Responsibilities, sole parent responsibilities, financial hardship, English language difficulty, Indigenous Australian, long term medical conditions/disability or ongoing effects of abuse, Refugee status, Regional or remote disadvantage.)

Excellence Scholarships

Excellence-based scholarships aim to attract and retain top students at the University of Newcastle. These scholarships can be established for a minimum amount of \$5,000 per year and are intended to recognise and reward students who excel in a particular area or discipline. Often this reflects recognition of academic achievements but may include sport, leadership, community participation, etc. These scholarships typically incorporate a Grade Point Average (GPA) and/or Australian Tertiary Admission Rank (ATAR) component, as academic achievement is the primary selection criteria.

These scholarships can also be established for a specific discipline.

Naming Recognition

In recognition of generosity, the University invites donors to name a scholarship in honour of someone they wish to acknowledge for annually funded or endowed scholarships that meet the minimum funding commitments set out below.

Undergraduate Scholarships

Note: For Annual Scholarships, donors can elect to pay the total gift amount at the time of pledge or can choose to pay on an annual basis; Donations under \$4,000 will be pooled with other donor funds to create Shaping Futures Scholarships or can be used to create a Prize if over \$2000.

PRIZES

Prizes are awarded annually to the top students in a Faculty, School or Program. Prizes are awarded on merit and based upon Grade Point Averages (GPA) grades received by students. Faculties and Schools have prize ceremonies at different times throughout the year to award and celebrate their top students. Prizes can be set up for a minimum of \$500 per year with a minimum commitment of 3 years. (\$1,500)

PhD Top-Up Scholarships

When studying a PhD, students are given a stipend that equates to approx. \$26,000 p.a. This allowance helps them live whilst they are engaging in their research. Many of the larger and wealthier Universities offer Top-up Scholarships to attract researchers to move to their Universities. To help keep our local researcher talent in the Hunter, donors can opt to offer a PhD Top-up Scholarship. Top-up PhD scholarships start at \$10,000 per annum.
